

ARTICLES OF INCORPORATION  
OF

WE, THE UNDERSIGNED being citizens of the United States, and being persons of full legal age, have this day voluntarily associated ourselves together with the purpose of forming a domestic corporation, under and pursuant to the laws of the State of Idaho, and do hereby certify:

FIRST: The name of this corporation shall be IDA-SAGE DISTRIBUTING CO., INC.

SECOND: This corporation is being formed for the purpose of engaging in the sale of farm machinery, implements, parts and accessories and for any other lawful business activity for which corporations may be organized under the laws of Idaho.

THIRD: The period of existence and duration of the life of this corporation shall be perpetual.

FOURTH: The location and post office address of the registered office and agent of the corporation in the State of Idaho shall be:

SIXTH: The names and post office addresses of each of the incorporators of this corporation are as follows:



