ARTICLES OF INCORPORATION
OF
GOLDUST KAR KORRAL, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of full age and citizens of the United States of America, and the State of Idaho, in order to form a corporation for the purposes hereinafter stated pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

ARTICLE I.

The name of the corporation shall be GOLDUST KAR KORRAL, INC.

ARTICLE II

The purposes for which said corporation is formed are:

1. To acquire, buy, sell, trade, bargain and otherwise deal in and with all types and kinds of automobiles, trucks, tractors, trailers, buses, camp trailers, house trailers and all other types and kinds of chattels and all interest therein.
2. To acquire, purchase, sell and otherwise deal in contracts, mortgages, trust deeds and all other forms of real property, securities, equities and interests.
3. To invest in lands and all forms of real and personal property, and to buy, sell, hypothecate, mortgage, pledge, bargain, trade, acquire and dispose of in any way or manner whatsoever all forms of realty and personality.
4. To loan and/or borrow money on realty, personality or interests therein and to otherwise deal in any way or manner whatsoever in tangible or intangible property interest, both real and personal.
5. To own and hold real and personal property and to rent or lease the same.
6. To do any and all things necessary, reasonable, proper,

convenient or incident to carrying out the purposes for which this corporation is formed.

7. To borrow money and to pledge, mortgage or hypothecate corporate property, or in any way or manner secure the payment of same.

8. To enter into any and all contracts with respect to the purposes for which this corporation is formed.

9. To conduct business in this State or any other States, District of Columbia, territories and colonies of the United States and foreign countries or territories, and to maintain one or more places of business outside of this State, and to receive, purchase, hold, acquire, mortgage, assign, transfer, lease, release, convey and otherwise deal in and with any chattels, real or personal property or any interests therein either within or outside the State of Idaho, reasonably calculated to promote the purposes hereinabove stated to this corporation.

10. To acquire the operating name, good-will, property rights, and the whole or any part of any estate, tangible or intangible, and of any business, and to assume the liabilities of any person, firm, association, corporation or other business organization and pay for said good-will, property rights and assets in cash and the stock of this corporation, it's bonds, it's debentures, or otherwise, or by undertaking the whole or any part of the liabilities of the transferor thereof, and to hold in any manner or dispose of all or any part of the property so acquired.

11. To conduct in any lawful manner the whole or any part of any business so acquired and to exercise all the powers necessary and expedient in and about the conduct and management of such business or businesses, directly or indirectly related to the purposes

and objects of this corporation, or though not so connected, to preserve or protect the assets of this corporation.

12. To purchase, insofar as the same may be done without impairing the capital of this corporation, except as otherwise prohibited by law, and to hold, pledge and reissue shares of it's own capital stock, but such stock so acquired and held shall not be entitled to vote nor receive dividend.

13. To have, exercise, enjoin and participate in all the powers now or hereafter granted to corporations organized under the laws of this State, and particularly all of the powers and privileges granted to corporations by Chapter I, Title 30, I.C., including any future amendments thereto, and to do any act or thing necessary or convenient for the transaction of the aforesaid business or businesses and for the carrying into effect of any and all the objects and purposes of this corporation.

14. To conduct in any lawful manner the whole or any part of a general lines insurance business reasonably calculated to promote the welfare of this corporation.

15. To do all things which a natural person might do, it being expressly provided that the aforesaid enumeration of purposes shall not be construed to be limitations upon the powers and purposes of this corporation.

ARTICLE III

The corporation is to have perpetual existence.

ARTICLE IV.

The location and post office address of the registered office of the corporation is 3147 Chinden Blvd., Boise, Ada County, Idaho.

ARTICLE V

The total number of par value shares is 100, the par value per share being \$100.00 and the total capital of the corporation is

\$10,000.00. All stock of the corporation is of one classification, to-wit: COMMON STOCK. Each share has the same rights, preferences and voting power.

ARTICLE VI


