KNOW ALL MEN BY THESE PRESENTS: 88 DEC 7 AM 9 11

That the undersigned, acting as incorporator of J. C. Uhling Products Company, a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation;

FIRST:

The name of the corporation is J. C. Uhling Products Company.

SECOND:

The period of duration is; perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are; the transaction of any lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares of voting common with a par value of \$10.00 per share.
