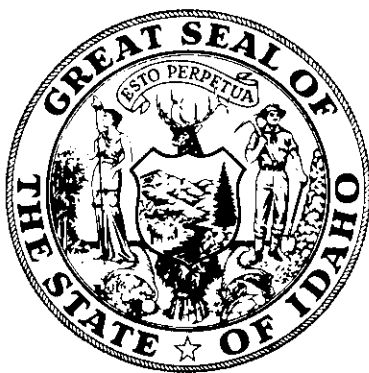

ARTICLES OF INCORPORATION
OF
MITCHELL AND DOROTHY GREENZANG CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, acting as incorporaters under the Idaho Business Corporation Act, adopt the following Articles of Incorporation.

SECTION 1:

The name of the corporation is Mitchell And Dorothy Greenzang Corporation.

SECTION 2:

The period of its duration is perpetual.

SECTION 3:

The purpose or purposes for which the corporation is organized are: Investment in real property for profit, together with the transaction of all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

SECTION 4: Stock:

The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares of common stock at the par value of \$1.00 per share.

SECTION 5: Corporation Regulations:

The internal affairs of Mitchell And Dorothy Greenzang Corporation shall be regulated by such by-laws as may be provided for the corporation and in addition shall be regulated in accordance with the provisions of the Idaho Business Corporation Act, Section 30-1-23(a).

SECTION 6: Registered Office:

The address of the initial registered office of Mitchell And Dorothy Greenzang Corporation is 350 E. Cedar, Pocatello, Idaho, and the name of its initial registered agent at such address is Mitchell Greenzang.

SECTION 7: Corporate Directors:

The number of directors constituting the initial board of directors of Mitchell And Dorothy Greenzang Corporation is two (2). These directors shall serve as directors of the corporation until the first annual meeting of the share holders or until their successors are elected and qualified. 


