1 **ARTICLE IV**

2 The aggregate number of shares which the corporation shall have authority to  
3 issue is Five Thousand (5,000); the shares shall consist of one (1) class only; the par  
4 value of each share shall be the sum of Ten Dollars (\$10.00); the total authorized capital  
5 stock of the corporation is the sum of Fifty Thousand Dollars (\$50,000.00). The stock  
6 of this corporation shall be nonassessible.

8 **ARTICLE V**

9 The physical address of the initial registered office of the corporation is 1810  
10 Ellis, Orofino, Idaho 83544. The name of the initial registered agent of the corporation  
11 at the initial registered office of the corporation is Dan A. Weaver. The mailing address

14 **ARTICLE VI**

15 The corporation shall have three (3) directors except in the event that all of the  
16 shares of the corporation are owned beneficially and of record by fewer than three (3)  
17 shareholders in which event the number of directors may be fewer than three (3) but not  
18 fewer than the number of shareholders.

20 The initial Board of Directors shall consist of one (1) director. The name and

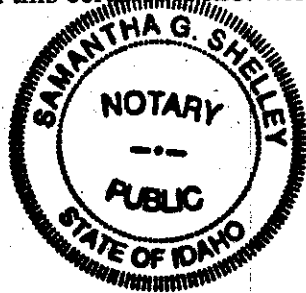

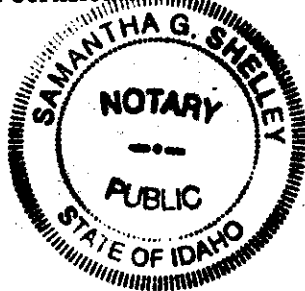
