

ARTICLES OF INCORPORATION  
OF  
RIVER CITY INTERIORS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is RIVER CITY INTERIORS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are to purchase and sell all types of building supplies at wholesale and retail, and to provide instruction, advisory and related services, and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares, with a par value \$100.00 per share.

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: The internal affairs of the corporation shall be governed by a duly adopted Code of Bylaws which shall be consistent with these Articles of Incorporation and the laws of the State of Idaho.

SEVENTH: The address of the initial registered office of the corporation is Post Office Box 697, (1st & High Streets) Priest River, Idaho 83856, and the name of the registered agent at such address is Dwain D. Valez.
