ARTICLES OF INCORPORATION

OF

CO-AD, INC.

We, the undersigned, being five or more natural persons of full age, at least two-thirds of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private non-profit corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLE I - NAME

The name of the corporation is CO-AD, Inc.

ARTICLE II - PURPOSE

The purposes of the corporation are: to bring together into a coalition the volunteer agencies within the State of Idaho serving the disabled population; to develop a statewide network of advocates for the disabled; to advocate for the disabled and their families when government systems fail to serve; to identify the disabled population within the State of Idaho; to develop a comprehensive listing of available benefits and services for the disabled and their families on local, county and state levels; and to provide legal assistance when necessary to insure the rights of the disabled.

ARTICLE III - POWERS

The corporation shall have the authority to exercise all powers allowed by law to non-profit corporations.

ARTICLE IV - DURATION

The duration of the corporation is perpetual.

ARTICLE V - ADDRESS

The location and Post Office address of the registered office of the corporation in the State of Idaho is:

ARTICLE VI - MEMBERSHIP

The corporation is to be organized on a non-stock basis. Certificates of membership will be issued to qualified members. Any corporation or association within the State of Idaho whose purposes include advocacy for disabled persons is eligible for membership upon request. Each member, through a designated representative, shall be entitled to one vote.

ARTICLE VII - INCORPORATORS
