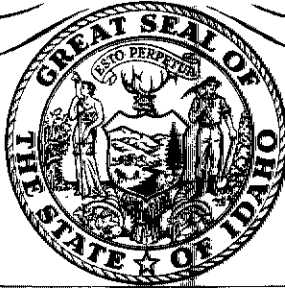

ARTICLES OF INCORPORATION OF

"GEORGE F. BROCKE & SONS, INCORPORATED"

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, each being natural persons of full legal age and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

FIRST

That the name of said corporation shall be:

"GEORGE F. BROCKE & SONS, INCORPORATED."

SECOND

That the existence or duration of said corporation shall be for the term of fifty (50) years.

THIRD

That the purposes for which said corporation is formed are to carry on the trade of warehouseman and to operate elevators and public warehouses for the purchase, sale, and storage of farm products and by-products; to buy and sell on commission or otherwise, at wholesale or retail, all kinds of farm produce, particularly beans, peas, and lentils; to own real and personal property and to buy, sell, lease, and mortgage real and personal property; to purchase, own, operate, and develop farms, farm lands, stock farms and grazing lands and to buy, raise, sell or otherwise deal

in cattle, hogs, and all kinds of livestock; to buy, sell, trade, and deal in, at wholesale or retail, hardware, appliances, machinery, and goods, wares and merchandise of all kinds for farm or home use; and to do all legal, necessary, and proper things in pursuance of the foregoing stated objectives and purposes.

FOURTH

That the location and post-office address of the registered office of said corporation shall be Kendrick, Latah County, Idaho.

FIFTH

That the capital stock of this corporation shall be One Hundred Fifty Thousand Dollars (\$150,000.00) divided into one hundred fifty thousand (150,000) shares of common stock of the par value of One Dollar (\$1.00) each.

SIXTH

That the number of directors of said corporation shall be five (5), who must be shareholders of common stock of said corporation. That said directors shall be elected by the shareholders of said corporation. That at the meetings of the shareholders of said corporation cumulative voting shall be permitted.

SEVENTH
