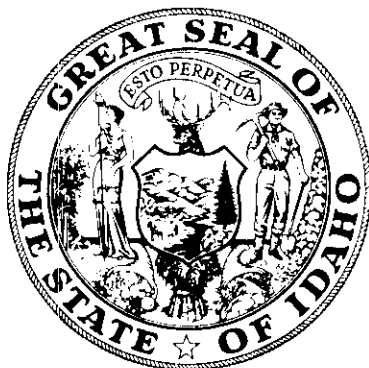




I, THE UNDERSIGNED, being over the age of twenty-one years, for the purpose of forming a corporation pursuant to Title 30, Chapter 1, Idaho Code, Idaho Business Corporation Act, do hereby certify:

- First: The name of the corporation is MIDSTATE DISTRIBUTING, INC.
- Second: The period of duration of the corporation is perpetual.
