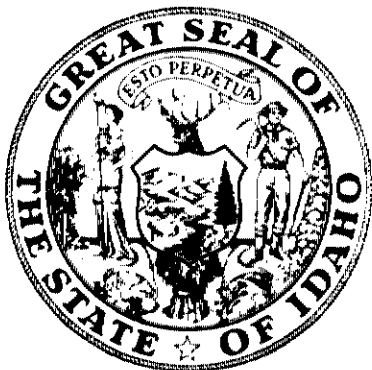

ARTICLES OF INCORPORATION

OF

VANCO, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, all citizens of the United States of America, being over the age of 18 years, do hereby associates ourselves together for the purpose of forming a corporation under and pursuant to the provisions of the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation:

ARTICLE 1

NAME OF CORPORATION: The name of the corporation shall be: VANCO, INC.

ARTICLE 2

PURPOSES: The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act. Additionally the corporation may act as a partner or in a joint venture.

ARTICLE 3

TERM: The corporation is to have perpetual existence.

ARTICLE 4

REGISTERED OFFICE AND REGISTERED AGENT: The registered office of the corporation shall be located at 2550 Overland Avenue, Burley, Idaho, 83318. The registered agent for the corporation shall be Vanness Anderson, 2550 Overland Avenue, Burley, Idaho 83318, whose business office is identical with the registered office of the corporation, and whose mailing address is Box 789, Burley, Idaho 83318.

ARTICLE 5

CORPORATE STOCK: The total number of shares which the corporation is authorized to issue is 2500 shares without par value.

1           The Board of Directors may from time to time fix the  
2 consideration for which such shares shall be issued and sold,  
3 provided they may not be issued or sold at a value less than par.  
4 The capital stock when fully paid, shall be nonassessable, and  
5 shall be one class of which all shall be voting. Voting of the  
6 stock shall be cumulative.

13           DIRECTOR: The initial Board of Directors shall consist

19 meeting of the shareholders at which time his respective succes-

22                           ARTICLE 8

23           CONTRACTS: No contract or other transaction between  
24 the corporation or any other corporation, whether or not a  
25 majority of the shares of capital stock of such other corporation  
26 is owned by the corporation, and no act of the corporation shall  
27 be in any way affected or invalidated by the fact that any of the  
28 directors of the corporation are pecuniarily or otherwise inter-  
29 ested in or are directors or officers of such other corporation.  
30 Any director individually may be a part to or may be pecuniarily  
31 or otherwise interested in a contract or transaction of the

1 interested may be counted in determining the existence of a quorum  
2 at any meeting of the Board of Directors of the corporation shall  
3 authorize such contract or transaction and may vote thereon to  
4 authorize such contract or transaction with the same right, force  
5 and effect as if he were not such director or officer of such  
6 corporation and not so interested therein. The same shall apply  
7 if any officer or director of this corporation shall be interested
