ARTICLES OF INCORPORATION
OF THE EAST IDAHO FALLS

I, the undersigned, having been duly chosen and appointed President of the East Idaho Falls Stake of the Church of Jesus Christ of Latter-day Saints, in the County of Bonneville and State of Idaho, in conformity with the rites, regulations and discipline of said Church, being desirous of forming a corporation for the purpose of acquiring, holding and disposing of Church or religious society property, for the benefit of religion, for works of charity and for public worship, under and pursuant to the provisions of Chapter 12, Title 30, Idaho Code, 1947, of the State of Idaho, entitled "Corporations Sole" and all acts amendatory thereof and supplementary thereto, for that purpose do hereby make and subscribe, in duplicate, the following

ARTICLES OF INCORPORATION:

FIRST

The name of this corporation shall be the EAST IDAHO FALLS STAKE OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS.

SECOND

The object of this corporation shall be to acquire, hold and dispose of real and personal property, for the benefit of the members of the Church of Jesus Christ of Latter-day Saints (a religious society), residing, and who may hereafter reside in the East Idaho Falls Stake of said Church, in the County of Bonneville and State of Idaho, for works of charity and for public worship.

THIRD

The estimated value of the property of which I hold the legal title for the purpose aforesaid, at the time of making these Articles of Incorporation, is \$ None.

FOURTH

The title of the person making these Articles of Incorporation is, President of the East Idaho Falls Stake of the Church of Jesus Christ of Latter-day Saints, in the County of Bonneville and State of Idaho.

FIFTH

The corporate seal shall contain the words, "East Idaho Falls Stake of the Church of Jesus Christ of Latter-day Saints, Seal," and an impression thereof is hereto affixed.
