ARTICLES OF INCORPORATION STATE TOME, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Corporation Act, adopt the following Articles of

Ι

The name of this Corporation shall be TCME, INC.

Incorporation for this corporation.

ΙI

The period of existence and duration of the life of this corporation shall be perpetual.

III

The address of the initial registered office of this corporation is 1890 Ancestor, Boise, Idaho, and the name of the initial registered agent at such address is John L. Thompson.

IV

The nature of the business and the object and purpose of this corporation shall be as follows:

- (a) Owning, managing and operating a temperature control, maintenance and energy management business.
- (b) The transaction of any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

That the total authorized number of par value shares of this corporation shall be one hundred thousand (100,000), all of one class, each of a par value of \$1.00, which said shares shall be common stock and shall not be subject to assessment.
