The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of incorporation for such corporation:

FIRST: The name of the corporation is NIKI SPORTSWEAR INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To Manufacture and sell sportswear, together with any other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ONE HUNDRED [100] shares of common stock, with a par value of \$1.00 each.

FIFTH: This corporation shall be a closely held corporation.

SIXTH: The By-Laws of the corporation shall provide for a restriction on transfer of stock that provides the corporation with a first-purchase option upon such transfer.
