ARTICLES OF INCORPORATION

A. & P. DEVELOPMENT COMPANY

KNOW ALL MEN BY THESE PRESENTS:

we, the undersigned, being of full age, and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Business Corporation Act of the State of Idaho, and to that end do hereby adopt the following Articles of Incorporation:

ARTICLE I. The name of the corporation shall be A. & P. Development Company.

ARTICLE II. The purposes of the corporation are as follows:

To purchase or in any wise acquire for investment or for sale or otherwise, lands, contracts for the purchase or sale of lands, buildings, improvements, and any other real property of any kind or tenure or any interest therein, and any property works or undertakings connected with the use or development of any property of the company; and to sell, convey, lease, rent, mortgage, turn to account, or otherwise deal with all or any part of the property of the company.

To manage, improve, develop, and turn to account any land or contracts for purchase or sale of lands acquired by the company, or in which the company is interested, and, in particular, laying out town sites, establishing towns, and improving the same by laying out and preparing the same for building purposes, constructing, altering, and improving buildings thereon.

To manufacture, sell and distribute seed, feed, fertilizer, and purification and other pellets.

To own, operate, and maintain nurseries for the production of seed, and to buy, sell, receive, store, forward, and handle all cereals and products thereof; and to engage in the manufacture and sale of poultry and domestic animal feeds, hay, and grain, and

all types of ranch, farm, and garden supplies and equipment.

To own and operate any and all types of business necessary to carry out the objectives hereinabove set forth, and to own and operate any and all types of machinery and equipment necessary for the operation of any of the businesses herein described.

To acquire, construct, maintain and operate, control and manage any waterworks, irrigation works, reservoirs, streets, roads, public utilities, hotels, parks, and other works and conveniences which the company may think, directly or indirectly, conducive to these objects.

ARTICLE III. The period of existence and the duration of the life of this corporation shall be perpetual.

ARTICLE IV. The principal place of business and the location and post-office address of its registered office shall be Blanchard, Idaho.

ARTICLE V. The total authorized number of par value shares is 2,500. The aggregate par value of the total authorized number of par value shares is \$25,000.00.

ARTICLE VI. The stock of the corporation is divided into 2,500 shares of common stock.


