ARTICLE I

The name of the Corporation is R-N-R-, Incorporated.

ARTICLE II

The purposes for which the Corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

## ARTICLE V

## ARTICLE VI

No shareholder has any preemptive or preferential right to subscribe to or otherwise acquire any shares of stock of the Corporation, or any obligations or securities converted into or carrying options or warrants to purchase shares of stock of the Corporation, whether now or hereafter authorized and whether unissued or held by the Corporation as treasury stock (whether or not the issuance or sale of any such shares, obligations, or securities would adversely effect such shareholder's proportionate voting power) other than such rights, if any, as the Board of Directors in its discretion from time to time may grant, and at such price as the Board of Directors may fix.

## ARTICLE VII

The Corporation shall indemnify to the fullest extent permitted by the Idaho Business Corporation Act, any person who has been made, or is threatened to be made, a party to an action, suit, or proceeding, whether civil, criminal, administrative, investigative, or otherwise (including an action, suit or proceeding by or in the right of the Corporation), by reason of the fact that the person is or was a director or officer of the Corporation, or a fiduciary within the meaning of the Employee Retirement Income Security Act of 1974 with respect to an employee benefit plan of the Corporation, or serves or served at the request of the Corporation as a director, or as an officer, or as a fiduciary of an employee benefit plan of another corporation, partnership, joint venture, trust, or other enterprise.

## ARTICLE VIII

The Corporation shall have the right to purchase, directly or indirectly, its own shares to the extent of unreserved and unrestricted surplus available therefore.
