

Idaho Code, the undersigned Corporation adopts the
following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Spirit Lake

SECOND: The following Amendment of the Articles of
Incorporation was adopted by the Trustees of the Corporation on
the 20th day of July, 1989, in the manner prescribed by the
Section 30-326, Idaho Code:
