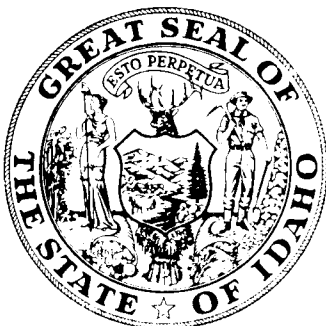

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF
STEGNER GRAIN & SEED COMPANY**

Pursuant to the provisions of Idaho Code § 30-1-59, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The present name of the corporation is Stegner Grain & Seed Company.

SECOND: The following amendment of the Articles of Incorporation was adopted by the unanimous written consent of the shareholders of the corporation pursuant to § 30-1-145, Idaho Code.

"That Article 1 of the Articles of Incorporation be amended to change the name of the corporation from "Stegner Grain & Seed Company" to "Means Company", and, to that end, that Article 1 as now written be deleted and that the following language be substituted therefor:

"Article 1.


"The name of this corporation shall be


