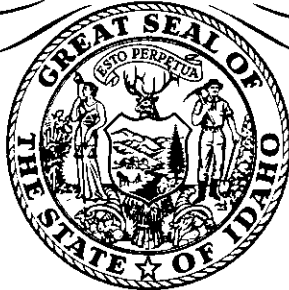

### CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

#### **BAUER CHEVROLET COMPANY**

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the **Fifteenth** day of **March,** 19 **65**, original articles of amendment, as provided by Section **s 30-146 and 30-147, Idaho Code,** amending **ARTICLE FOURTH,** changing the number of shares of stock subscribed from **5,200 to 2,261** and the amount paid in in exchange for from **\$52,000.00 to \$22,610.00,**

and that the said articles of amendment contain the statement of facts required by law, and <sup>will be</sup> ~~are~~ recorded on ~~film~~ **microfilm** of Record of Domestic Corporations of the State of Idaho.

AMENDMENT OF ARTICLES OF  
INCORPORATION

RICHARD L. BAUER, President, and Lois S. Bauer, Secretary, of the above-named corporation respectfully show that:

The above named corporation was organized under the laws of the State of Idaho and was issued a charter by the Secretary of State dated September 12, 1963, with its principal place of business at American Falls, Power County, Idaho and with a capital stock of \$100,000.00 divided into 10,000 shares, of the par value of \$10.00 each.

The undersigned, the duly elected and qualified President and Secretary of the said Corporation hereby certify that thirty (30) days written notice was mailed to each shareholder of said Corporation of a special meeting of said stockholders which notice stated the time and place of meeting and the purpose thereof.

And, further, that the meeting was duly held pursuant to notice, and a resolution was offered and unanimously adopted by vote of said stockholders to amend Article Fourth and Article Seventh of the Articles of Incorporation of said Corporation to read as follows:

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is: 10,000 shares with a par value of \$10.00 per share for a total capitalization of \$100,000.00; \$22,610.00 in stock has been subscribed for and paid in in exchange for 2,261 shares of stock.

SEVENTH: The names, addresses, and numbers of shares of stock held by each incorporator are as follows:
