At the denotable quarterly ensiners meeting 13 July 1980, the dissolution classe of the Articles of Interporation of Trinity Baptist Church, Inc. of Priest River, Idam were amended as follows:

This corporation is organized exclusively for religious purposes within the meaning of Section 501 (a) (3) of the Internal Revenue Code. Not withstanding any other provision of these articles, the corporation shall not surry on any other activities not permitted to be carried on by an organization exempt from Rederai Income Tax under Section 501 (c) (3) of the Internal Revenue Code.

Upon the winding up and dissertation of this corporation after paying or adquately providing for the debts and obligation of the organization, the remaining assets shall be distributed to an non-profit fund, foundation or corporation which has established its tax exempt status under Section 501 (c) (3) of the Internal kevenue Code.

This amendment was adopted by the membership by unanimous vote of the members present, a quorum was present as required.
