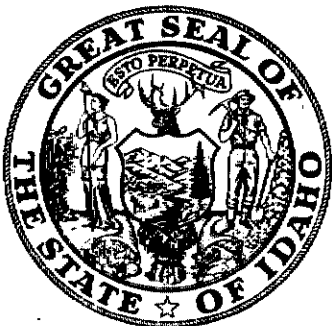

ARTICLES OF INCORPORATION

OF

WILDER ROD AND GUN CLUB, INC.

We, the undersigned, desiring to form a nonprofit corporation under the statutes of the State of Idaho, do hereby make, subscribe and acknowledge as follows:

ARTICLE ONE

NAME

The name of the corporation is WILDER ROD AND GUN CLUB, INC.

ARTICLE TWO

PURPOSE

The corporation is organized for the purpose of encouraging, promoting, and educating its members and the general public in the principles of safety and the use of firearms; promoting and encouraging better understanding between its members and other sportsmen and landowners; promoting and encouraging the conservation of all wildlife in the State of Idaho; establishing, operating and maintaining trap and skeet fields; encouraging, promoting and fostering the health, education and welfare of people living in or near the community of Wilder, Idaho; and for the purpose of reinstating the corporation of the same name originally incorporated on or about the 2nd day of September, 1955.

### **ARTICLE THREE**

#### **NONPROFIT PURPOSE**

This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code. The corporation is formed exclusively for purposes which are not for profit, and not for pecuniary profit or financial gain. No part of the corporate assets, income or profits shall be distributable to, or inure to the benefit of its officers, directors or members, except to the extent permitted for a nonprofit corporation under the nonprofit corporation laws of the State of Idaho and Section 501(c)(3) of the Internal Revenue Code. The corporation shall not take steps which serve to facilitate the transaction of specific business by its officers, directors, or members; or promote the private interest of any officer, director or member; or engage in any activity which would constitute a regular business of a kind ordinarily carried on for profit. .

### **ARTICLE FOUR**

#### **DURATION**

The period of the duration of this corporation is perpetual.

## **ARTICLE FIVE**

### **MEMBERS**

There shall be one class of members. The conditions and regulations of membership and the rights and other privileges of membership shall be determined and fixed by the By-laws.

## **ARTICLE SIX**

### **REGISTERED OFFICE**

#### **AND AGENT**

The post office address of the corporation's registered office is 28502 Shelton Road, Parma, Idaho 83660. The initial registered agent at such address is Douglas G. Batt.

## **ARTICLE SEVEN**

### **DIRECTORS**

#### **ARTICLE EIGHT**

##### **DISTRIBUTION ON DISSOLUTION**

##### **OR LIQUIDATION**

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation, which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

#### **ARTICLE NINE**

##### **AMENDMENTS**

These Articles of Incorporation may be amended from time to time in any manner lawful under the Nonprofit Corporation Act of the State of Idaho.
