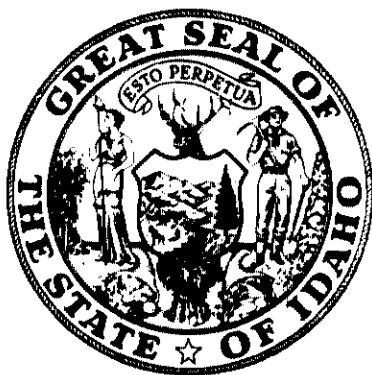

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

R.V.P., INC.

Pursuant to the provisions of the Idaho Business Corporation law, the undersigned corporation adopts the following Articles of Amendment to it's Articles of Incorporation:

ARTICLE I

The name of the corporation is R.V.P., Inc.

ARTICLE II

The following amendments of the Articles of Incorporation was adopted by the Stockholders of the corporation on the 8 day of July, 1983, in the manner prescribed by I.C. sec. 30-146:

Article V of the Articles of Incorporation is hereby deleted and replaced with the following provision;

"The shares of stock of said corporation shall all be common stock. The shares of stock of said corporation shall be one thousand (1,000) in number of the par value of one ~~thousand~~ <sup>hundred</sup> and no/100 dollars ~~(\$1,000.00)~~ <sup>(\$100.00)</sup> Said shares of stock shall be fully paid up before being issued and after issuance shall be non-assessable."

ARTICLE III

The number of shares of the corporation outstanding at the time of such adoption was 1,000; and the number of shares entitled to vote thereon was 669 shares.


ARTICLE IV


All outstanding shares were common stock of which 331 shares were held by the corporation as treasury stock and of which 669 shares were entitled to vote.

ARTICLE V

The number of shares voted for such amendment was 669 and the number of shares voted against such amendment was none.
