ARTICLES OF INCORPORATION

NORMAN MANOR, INC.

FIRST: This is to certify that we,

Norman Thompson	1355 North 5900 West	Ogden, Utah
Roger F. Rawson	4000 South 5125 West	Hooper, Utah
Alma C. Clark	290 Grandview	Burley, Idaho

all being of full legal age and citizens of the United States, do, pursuant to the Business Corporation Act of the State of Idaho, associate ourselves with the intention of forming a Limited Dividend Housing corporation exclusively to provide housing for the use and occupancy by families displaced from urban renewal areas or by governmental action and families of low and moderate income under the conditions hereinafter set forth.

SECOND: The name of the corporation is Norman Manor, Inc. The corporation shall commance business with the filing of these articles, and have perpetual existence. The principal office of the corporation will be located at Burley, Idaho. The resident agent of the corporation is Alma C. Clark, whose post office address is 290 Grandview, Burley, Idaho, 83318.

THIRD: The purpose for which the corporation is formed, and the business and the objects to be carried on and promoted by it, are as follows:

d.

(a) To construct, operate, maintain and improve, and to buy, own, sell, convey, assign, mortgage or lease any real estate and any personal property necessary to the operation of the project.

(b) To borrow money and issue evidences of indebtedness in furtherance of any or all of the objects of its business; to secure the same by mortgage, pledge or other lien.

(c) To apply for and obtain or cause to be obtained from the Federal Housing Commissioner, hereinafter called the "Commissioner", a contract or contracts of mortgage insurance pursuant to the provisions of Section 22l(d)(3) of Title II of the National Housing Act, as amended, covering bonds, notes and other evidences of indebtedness issued by this corporation and any indenture of mortgage securing the same,

(d) To enter into any kind of activity, and to perform and carry out contracts of any kind necessary to, or in connection with, or incidental to the accomplishment of the purposes of the corporation.

FOURTH: Notwithstanding any other provision contained herein the corporation formed hereby is authorized to enter into a contract (Regulatory Agreement) with the Federal Housing Commissioner and shall be bound by the terms thereof to enable the Commissioner to carry out the provisions of the National Housing Act, as amended. Upon execution, the contract (Regulatory Agreement) shall be binding upon the corporation, its successors and assigns, so long as a mortgage is outstanding, unpaid, and insured or held by the Federal Housing Commissioner.

FIFTH: The corporation shall have an odd number of directors, not less than three, as fixed by the By-Laws, who shall be elected by the stockholders of the corporation and who shall serve until their successors are elected and qualified.

SIXTH: The total number of shares which this corporation is authorized

SEVENTH: By-Laws of the corporation may be adopted by the stockholders, who may change them at their pleasure so long as they do not conflict with the provisions of these articles, or of the Regulatory Agreement.

EIGHTH: These articles, except Article Fourth thereof, may be amended by 2/3 wote of the stockholders of the corporation at any annual meeting, or at a special meeting called for that purpose.
