

Pursuant to Idaho Code Sections 30-303, 30-1-44 and 30-1-61, the undersigned Directors and Incorporator, being all of the Directors and Incorporators named in the Articles of Incorporation of Blaine County Breast Cancer Detection Clinic, Inc., a non-profit corporation (hereinafter the "Corporation") the Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The name of the Corporation is Blaine County Breast Cancer Detection Clinic, Inc.

**SECOND:** No members have been appointed to membership in the Corporation;

**THIRD:** The following Amendment of the Articles of Incorporation was adopted by the unanimous consent of the Directors and Incorporator of the Corporation in the manner prescribed by the Idaho Non-profit Corporations Act, I.C. Section 30-303 and the Idaho Business Corporation Act, I.C. Section 30-1-61:

WHEREFORE IT IS HEREBY RESOLVED the Corporation shall no longer be a membership corporation and shall have no members, pursuant to I.C. Section 30-308(a).

WHEREFORE IT IS HEREBY RESOLVED, the Board of Directors shall be elected by Mollie Scott Clinic, Ctd., an Idaho Business Corporation, pursuant to I.C. Section 30-315(e).
