KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the General Corporation Laws of the State of Nevada.

I.

That the name of this corporation is: RAYMOND F. ROBINSON, INC.

II.

within the State of Nevada is at 555 South Center Street, Mano,
Washoe County, Nevada. By resolution, or other action of the
Board of Directors, other offices and locations for the transaction
of the general business of the corporation and business, financial
and transfer offices may be established and business conducted
elsewhere in the State of Nevada and in such other places in the
United States and its territories and in foreign countries as may
be convenient, necessary or proper for the transaction of the
company's business affairs.

III.

The nature of the business and the objects and purposes for which this corporation is formed are to engage in any and all lawful activities.

The total authorized capital stock of this corporation is TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00) divided into twenty-five shousand (25,000) shares of common stock of the par value of
