
**'CERTIFICATE OF INCORPORATION

STATE OF IDAHO

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Dennis Dillon Truck & Used Car Center, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under Idaho law.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 5,000, all of \$1.00 par value.

ARTICLE V

There are no provisions denying preemptive rights to shareholders.

ARTICLE VI

Provisions for the regulation of the internal affairs of the corporation are set forth in the By-Laws of the corporation adopted by the Board of Directors.

ARTICLE VII

The address of the initial registered office of the corporation is 3403 Arthur, Caldwell, Idaho, 83605 and the name of its initial registered agent at such address is Mr. James D. Gonsalves.

ARTICLE VIII

The number of directors constituting the initial board of directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:


