FIRST, The name of the corporation is Hilber Nelson Designs, Inc.

SECOND, Its registered office in the state of Idaho is to be located at 2410 Rostron Circle, Twin Falls, ID 83301, County of Twin Falls. The registered agent in charge thereof is Hilber P. Nelson.

THIRD, The nature of business and objects and purposes proposed to be transacted, promoted and carried on are to engage in any lawful act or activity for which corporations may be organized under the Corporation Laws of the State of Idaho.

FOURTH, The amount of total authorized capital stock of the corporation is divided into 100 shares of No Par Common Stock.

FIFTH, The name and address of the incorporator is as follows: Hilber P. Nelson, 859 Westwind Dr, Twin Falls, ID 83301.

SIXTH, The powers of the incorporator are to terminate upon the filing of the certificate of incorporation and the name and mailing address of the persons who are to serve as directors until their successors are elected are as follows. The corporation will be perpetual.

SEVENTH, All of the corporations issued stock, exclusive of treasury shares shall be held of record by not more than thirty (30) persons.

EIGHTH, All of the issued stock of all classes shall be subject to the following restrictions on transfer permitted by Section 202 of the General Corporation Law.

Each stockholder shall offer to the Corporation or to other stockholders of the corporation a thirty (30) day "first refusal" option to purchase his stock should he elect to sell his stock.

NINTH, The corporation shall make no offering of any of stock of any class which would constitute a "public offering" within the meaning of the United States Security Act of 1933, as it may be amended from time to time.
