ARTICLES OF INCORPORATION

OF

NORTHERN IDAHO PONY OF THE AMERICAS CLUB, INC.

A Non-Profit Organization

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are of full age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho, and we do hereby certify:

I.

That the name of the corporation shall be NORTHERN IDAHO PONY OF THE AMERICAS CLUB, INC.

II.

The purposes for which this corporation is formed are:

1. To bring together persons who for pleasure and recreation engage in the hobby of breeding, raising, riding and showing of the breed of horses known as "Pony of the Americas" for the purposes of:
 - a. Aiding the programs and functions of the International Pony of the Americas Club, Inc.
 - b. Promoting interest in the above mentioned breed of horses.
 - c. Establishing breed and performance classes for ponies registered in the International Pony of the Americas Club, Inc., in local, county, district, and state pony shows and fairs in the State of Idaho.
 - d. Sharing ideas pertaining to the breeding, raising, and showing of the above mentioned breed of horses.
 - e. Doing of all other things necessary, convenient, or proper to further the development of the above mentioned breed of horses.

2. This corporation shall not engage in any business, trade, avocation or profession for pecuniary profit or gain and no dividends or pecuniary benefits shall be declared or paid to the members thereof.

III.

Subject to the dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

IV.

The principal place of business, registered office and location and Post Office address of the registered office of said corporation shall be Box 32, Route #1, Coeur d'Alene, County of Kootenai, State of Idaho.

V.

The rights and interests of all members of this club shall be equal and no member shall have or acquire a greater interest than any other member. This association shall not issue any capital stock, but shall issue membership certificates to each member thereof, which certificate cannot be assigned so that the transferee thereof can by such transfer become a member of the association, except by resolution of the Board of Directors and under such regulations as the By-Laws of this association may prescribe.

VI.

The number of the Directors of said corporation shall be nine (9) to be elected for two year terms provided however that four members of the first Board of Directors shall be elected for one year term and five members shall be elected for two year terms. Thereafter all members shall be elected for two year terms. If not otherwise elected as a Director, the immediate Past President of the corporation shall be an ex-officio member of the Board of Directors in addition to the nine elected Directors.

VII.

These Articles may be amended at a meeting of the shareholders duly called upon notice of the specific purpose by the vote of the majority of the members of the corporation. Any amendment which might be adopted at a meeting of the members as provided herein may be adopted without such meeting being held if written consent to the amendment has been given by all shareholders entitled to vote thereon as provided in this section.

VIII.

The By-Laws of this club may be altered, amended, or new By-Laws adopted at any regular meeting or at any special meeting of the members hereof called for that purpose, by the affirmative vote of two thirds (2/3) of the members present at such meeting, provided, that a majority of the members of the corporation are present at such meeting.

IX.

Upon the dissolution of this corporation, any surplus funds shall be distributed to a non-profit organization or organizations as designated by the Board of Directors at the time of said dissolution.
