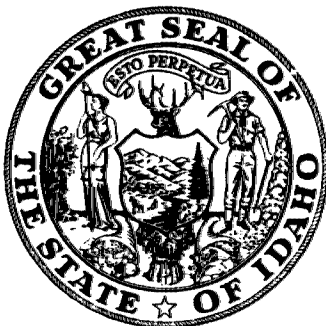

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, being of full legal age and a citizen of the United States, has this day voluntarily formed a corporation under the laws of the State of Idaho, and hereby adopts Articles of Incorporation as follows:

I

The name of the corporation shall be Performing Arts & Humanities of Sandpoint, Inc.

II

The corporation shall be nonprofit. No part of any income of the corporation will be distributable to its members, directors or officers.

III

The period and duration of the corporation shall be perpetual.

IV

The corporation is organized exclusively for educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Service Code.

V

The initial board of directors of the corporation shall

No part of the assets of the corporation

shall be distributed to members or private individuals for any purpose.


