SECOND AMENDED
ARTICLES OF INCORPORATION
OF
DR. ROD EMORY, D.D.S., P.A.

The undersigned, holder of all outstanding 100 shares of the corporation entitled to vote on these articles of amendment under the Idaho Professional Service Corporation Act, adopt the following Amended Articles of Incorporation as of the 2nd day of September, 1994, for such corporation by amending Article I, and all other Articles of Incorporation not so amended are restated:

ARTICLE I

The name of the corporation is PEDIATRIC DENTISTRY ASSOCIATES, P.A.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are the transaction of the practice of dentistry and any and all lawful business for which corporations may be incorporated under the Idaho Professional Business Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100 shares of \$10.00 par value for an aggregate authorized capital of \$1,000.


