

ARTICLES OF INCORPORATION

OF

**AMERICAN SOCIETY FOR PHYTOTHERAPY
& AROMATHERAPY INTERNATIONAL, INC.**

I, the undersigned, a natural person of the age of twenty-one years or more, acting as an incorporator under the Idaho Code Section 30 Chapter 3 concerning Non-Profit Corporations adopt the following articles of Incorporation.

ARTICLE I - NAME

The name of this Corporation is AMERICAN SOCIETY FOR PHYTOTHERAPY & AROMATHERAPY INTERNATIONAL, INC.

ARTICLE II - NON PROFIT STATUS

This Corporation is a non-profit corporation organized pursuant to Idaho Code Section 30 Chapter 3.

ARTICLE III - DURATION

The duration of this Corporation is perpetual.

ARTICLE IV - PURPOSE

The nature of the activity or purposes to be conducted or promoted is the promotion of the art of phytotherapy and aromatherapy, the exchange of information and education of the members of the society and all other activities allowed by law.

ARTICLE V - MEMBERS

The members of the corporation shall be composed of all persons who join the society. The bylaws shall set forth the different classes of members and their respective voting rights. Each member shall retain voting rights as long as they have paid current membership dues. Yearly dues shall be set by the board of directors.

ARTICLE VI - SHARES

The corporation shall issue no shares of stock, but will issue certificates of membership to all who join the society.

ARTICLE VII REGISTERED OFFICE AND AGENT

The location of this Corporation's initial registered office is, 105 S. Main, Pocatello, Idaho, 83204. The name of the registered agent is Ronald George.

ARTICLE VIII - ORIGINAL DIRECTORS

The number of directors constituting the initial Board of Directors of this Corporation shall be three (3). Their names and addresses are as follows:


