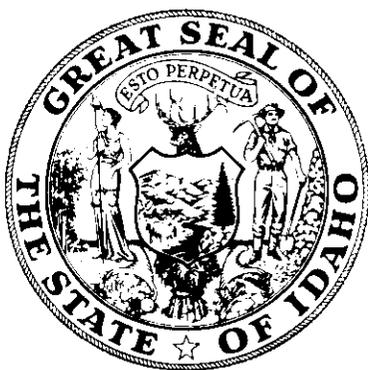

ARTICLES OF INCORPORATION  
OF  
RUPERT ANIMAL HOSPITAL, P.A.

The undersigned, acting as incorporator of a professional service corporation under the Idaho Professional Service Corporation Act as contained in Title 30, Chapter 13, Idaho Code, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Rupert Animal Hospital, P.A.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is to engage in, conduct and carry on the practice of veterinary medicine and allied professional services.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one hundred thousand (100,000) shares with a par value of One Dollar (\$1.00) per share, only in accordance with the provisions of the Professional Service Corporation Act.

FIFTH: No shareholder of the corporation may sell or transfer his shares in such corporation except to another individual who is eligible to be a shareholder of such corporation and as provided by Section 30-1310, Idaho Code. The shareholders of the corporation may adopt Bylaws restraining the alienation of shares and providing for the purchase or redemption by the corporation of its shares, so long as the purchase or redemption by the corporation is not invoked at a time or in a manner that would impair the capital of the corporation.

SIXTH: The address of the initial registered office of the corporation is 200 South, 200 West, Route #2, Box 212, Rupert, Minidoka County, Idaho 83350, and the name of its initial Registered Agent at such address is R. Kelley Chamberlain, D.V.M.

SEVENTH: The number of Directors constituting the initial Board of Directors of the corporation is one, and the name and address of the person who is to serve as the Director until the first annual meeting of the shareholders or until his successor is elected and shall qualify is:

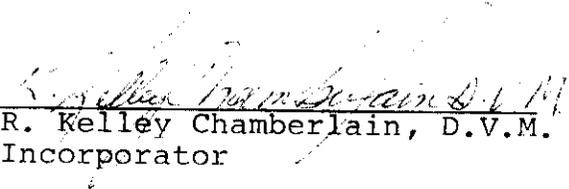
