ARTICLES OF INCORPORATION

The undersigned, acting to incorporate a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

SECRETARY OF STATE

1. **NAME:** The name of the corporation is TnT Marketing, Inc.
2. **DURATION:** The period of its duration is perpetual.
3. **PURPOSES:** This corporation may transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
4. **SHARES AUTHORIZED:** The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand (10,000) shares at \$1.00 par value common stock.
5. **PREEMPTIVE RIGHTS:** Shareholders shall have preemptive rights to acquire unissued or treasury stock or securities convertible into or carrying a right to subscribe to or acquire shares.
