7. The corporate directors have given consent for this dissolution and have submitted the same to the shareholders of the corporation..



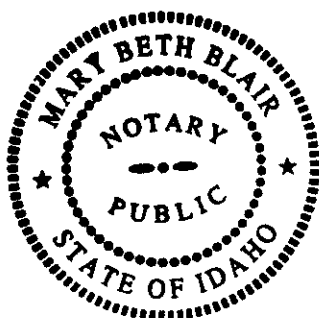
