

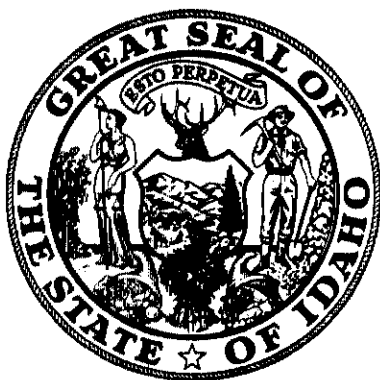
**CERTIFICATE OF INCORPORATION

**I**

The name of this corporation is **UNIQUE BUILDING SYSTEMS, INC.**

**II**

The period of duration for this corporation shall be perpetual.

**III**

The purpose for which the corporation is formed is the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho.

**IV**

The corporation shall have authority to issue 10,000 shares of stock with no par value.

**V**






