AMENDED AND RESTATED CERTIFICATE OF LIMITED

Pursuant to the provisions of Title 53, Chapter 2, Idaho Code, the undersigned, who are all of the partners, whether limited or general, in that certain limited partnership known as Big Wood River Ranch, who by these presence, do hereby amend and restate its Certificate of Limited Partnership, as originally filed with the office of the County Recorder of Blaine County, Idaho, on the 30th day of April, 1980, as amended, and as subsequently amended, restated and filed with the Secretary of State of the State of Idaho on the 28th day of June, 1982, as follows:

1. The name of the partnership is Big Wood River Ranch.
2. The purpose of the partnership is to carry on, in Idaho and elsewhere, the business of holding, operating, improving, subdividing, leasing and selling real property.
3. The location of the principal place of business of the partnership is P. O. Box 8861, Boise, Ada County, Idaho 83707, and its registered agent is Leonard L. Hurst, Jr., Rt. 3, Box 124, Caldwell, Idaho 83605.

5. The term for which the partnership is to exist shall be for an indeterminate period of time until the sale of all real property owned by the partnership, or upon voluntary dissolution by agreement of the partners.

6. The contribution of each partner to the partnership is as follows:

7. The limited partners are not obligated to make any additional contributions in excess of that amount set opposite each limited partner's name in Paragraph 6 above.

8. The contribution of each limited partner may be returned to him only upon dissolution of this partnership, or with the consent of the general partner and limited partners whose interests aggregate 25% of the partnership.

9. The share of profits which each partner shall receive by reason of his contribution is as follows:

10. A limited partner may sell or assign his interest in the partnership to another person on such terms and conditions as he may desire, provided that he shall first make his interest available for a period of thirty (30) days to the partnership or any individual partners upon the same terms and conditions. In addition, a limited partner may transfer or assign, without restriction, his partnership interest to any member of his family.

11. No additional limited partners may be admitted without the consent of all partners.

12. No limited partner shall have priority over any other limited partner, either as to contributions as to capital or as to compensation by way of income.

13. The death, retirement or incapacity of the general partner shall cause the partnership to terminate, unless all

of the limited partners agree to the continuation of the partnership business.

14. No limited partner has the right to demand and receive property other than cash in return for his contribution.

15. That this amended and restated Certificate of Limited Partnership does amend previously filed certificates by the replacement of James W. Barber, Jr., as general partner, and the substitution therefor of Leonard L. Hurst, Jr., as general partner, said replacement and substitution being made with the consent of all limited partners who, after the death of the general partner, have further consented to the continuation of the partnership as set forth above. This amendment also reflects the composition of the partnership after the withdrawal of Gary Bethke, 1419 Sweetwater Loop, Olympia, Washington 98502, as a limited partner with the consent of the partnership. This further amends the share of profits each partner is to receive as set forth in Paragraph 9 above.
