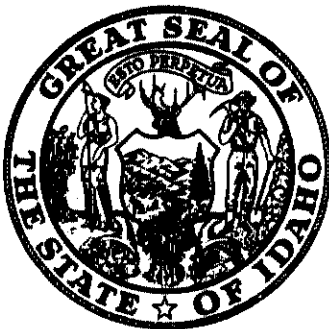
CERTIFICATE OF INCORPORATION OF

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is ROYAL RUSSET ENTERPRISES, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 200,000 shares of no par value stock; provided that the shareholders reserve the right to fix the consideration to be received by the corporation for the issuance of such shares.

ARTICLE V

There are no provisions denying preemptive rights.





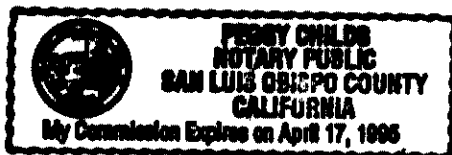
