OF

We, the undersigned President and Secretary, respectively, of WESLEY FOUNDATION OF IDAHO STATE, INC., hereby certify that pursuant to a call of special meeting jointly held of the Directors and Membership of this Corporation, all Directors and a quorum of the membership attending the said meeting, held on the 7th day of January, 1971, at 7:30, p.m. of said day in the principal office of the Corporation at Pocatello, Idaho, the following amendments to the existing Articles of Incorporation were adopted:

That Article I. of the Articles of Incorporation be amended to read as follows:

"ARTICLE I.

That the name of the Corporation shall be:

'IDAHO STATE UNIVERSITY ECUMENICAL MINISTRY, INC.'"

That Article II. of the Articles of Incorporation be amended to read as follows:

"ARTICLE II.

Idaho State University Ecumenical Ministry, Inc. is an organized ministry at Idaho State University. The purpose of Idaho State University Ecumenical Ministry, Inc. is to deepen, enrich, and mature the Christian faith of those participating in the academic community, recognizing that special disciplines of study, thinking, prayer and service are required for students,

faculty members, and administrators as they realize their.

Christian vocation on the college campus.

The purposes and objects of this Corporation shall be:

- 1. To conduct regular religious services.
- 2. To engage in charity and public service.
- 3. To provide for religious instruction for its congregation.
- 4. To provide a forum for discussion of public issues.
- 5. To own, maintain or provide a meeting place and other facilities and equipment for the conduct of the preceding activities."
