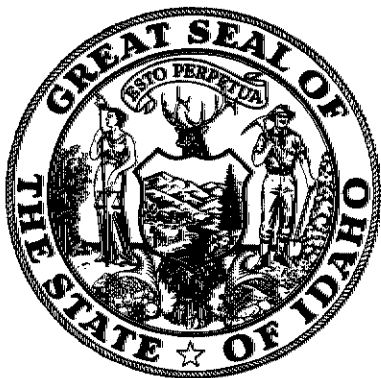
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

SECRETARY OF STATE

KNOW ALL MEN BY THESE PRESENTS; That I, the under-  
signed, being a natural person of full age and a citizen of  
the United States, in order to form a corporation for the  
purposes hereinafter stated, under and pursuant to the  
provisions of the general corporation laws of the State of  
Idaho, and the acts amendatory thereof and supplemental  
thereto, do hereby certify as follows:

FIRST

The name of the corporation shall be Continuing Care,  
Inc..

SECOND

The purpose for which the corporation is organized is  
for the transaction of any or all lawful business for which  
the corporation may be incorporated under the Idaho Business  
Corporation Act.

THIRD

The corporation is to have perpetual existence.

FOURTH

The location and post office address of the registered  
office of the corporation is 412 West Franklin, Boise, Idaho  
83702.

FIFTH

The aggregate number of shares which the corporation shall have the authority to issue is 1000 shares of \$1.00 par value stock.

SIXTH

EIGHTH

The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the corporation.

The Board of Directors is expressly authorized to repeal and amend the By-Laws of the Corporation and to adopt new By-Laws, and the Corporation reserves the right to amend, alter, change or repeal, any provision contained in these Articles of Incorporation, in the manner now, or hereafter prescribed by law, by a majority vote of the stockholders represented in person or by proxy, at any annual meeting of the stockholders or at any meeting duly called for that purpose, except where the laws of the said State of Idaho otherwise provide.
