The undersigned officer of Intermountain Multiple Listing Service, Inc., an Idaho Corporation, (formerly known as "Ada County Multiple Listing Service, Inc."), (the "Corporation") hereby submits the following Correction to the Corporation's Articles of Incorporation for filing with the Secretary of State of the State of Idaho:

1. Inaccurate Articles of Amendment were filed by the corporation and received by the Idaho Secretary of State on July 17, 1980.

2. Said Articles of Amendment included an inaccuracy and/or defect by the addition of the following:

"I.

The following statement shall be added to the Articles of Incorporation:

"The Ada County Multiple Listing Service, Inc., shall be a non-profit corporation pursuant to the Idaho Non-Profit Corporation Act."

II.

Article V of said Articles of Incorporation shall be amended by the addition of the following sentence:

"The corporation shall have no members, other than said Boise Board of Realtors, Inc."

III.

Said Articles of Incorporation shall be further amended by the addition of a new Article as follows:

"ARTICLE X

No dividends shall be paid and no part of the income of the corporation shall be distributed to the stockholder of this corporation, or any directors or officers of the corporation;

provided, however, the corporation may pay compensation in a reasonable amount to the stockholder or directors or officers of the corporation for services rendered and may confer benefits upon said stockholder, directors or officers in conformity with its purposes; provided, further, upon dissolution or final liquidation the corporation may make such distribution to the stockholder of this corporation as may be permitted by the Idaho Non-Profit Corporation Act."

3. Such inaccuracy and/or defect is corrected by striking and removing such aforestated language, and as such Intermountain Multiple Listing Service, Inc. hereby strikes and removes the same.

4. Inaccurate Articles of Amendment were filed by the corporation and received by the Idaho Secretary of State on December 22, 1993.

5. Said Articles of Amendment included an inaccuracy and/or defect by the addition of the following:

"Pursuant to the provisions of the Idaho Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation. . . .

. . . . "SECOND: The following Amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation, which Board is also the Multiple Listing Committee being all of the members of the corporation, by written action and consent dated August 6, 1993, and approved by the sole stockholder being the Ada County Association of Realtors, Inc., in the manner prescribed by the Idaho Non-Profit Corporation Act:"

Such inaccuracy and/or defect is corrected by striking and removing the reference to the "Idaho Non-Profit Corporation Act" and replacing such language with the "Idaho Business Corporation Act," and as such Intermountain Multiple Listing Service, Inc. hereby strikes and removes the same and makes the aforestated language substitutions. The corrected provisions read as follows:

"Pursuant to the provisions of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

To the Secretary of State of the State of Idaho

Pursuant to Title 30, Chapter 3, Idaho Code, the undersigned non-profit corporation amends its articles of incorporation as follows . .

...

. . . Reason: To change the geographical attribution to the name as set out in Section 30-3-90 Idaho Code. . .

. . . Each amendment consists exclusively of matters which do not require member approval pursuant to section 30-3-90, Idaho Code, and was, therefore, adopted by the board of directors. . . "

9. Such inaccuracy and/or defect is corrected by striking and removing the reference to the "Idaho Non-Profit Corporation Act" and references to Idaho Non-Profit Corporation Act code sections referenced therein and replacing such language with the "Idaho Business Corporation Act," and the appropriate Idaho Business Corporation Act code section references. As such Intermountain Multiple Listing Service, Inc. hereby strikes and removes the same and makes the aforestated language substitutions. The corrected provisions read as follows:

"ARTICLES OF AMENDMENT

(General Business)

To the Secretary of State of the State of Idaho

Pursuant to Title 30, Chapter 1, Idaho Code, the undersigned corporation amends its articles of incorporation as follows




