ARTICLES OF INCORPORATION
OF
ROYAL SUN WEST CARE CENTER, INC.

The undersigned natural person of the age of eighteen years or more, acting as incorporator under the Idaho Business Corporation Act, Idaho Code §30-1-1, et seq., adopts the following Articles of Incorporation:

ARTICLE 1. The name of this corporation is ROYAL SUN WEST CARE CENTER, INC. and its duration shall be perpetual.

ARTICLE 2. The term for which said corporation shall exist shall be in perpetuity.

ARTICLE 3. The corporation is organized for the principal purpose of providing health care services and may engage in all activities which are authorized under the Idaho Business Corporation Act.

ARTICLE 4: The aggregate number of shares which the corporation shall have authority to issue is 1,000, with a par value at \$0.10 per share.

ARTICLE 5: The address of the initial registered office of the corporation is: 305 West Fort Street, Boise, Idaho 83702, and the name of its initial registered agent at such address is: Myron Dan Gabbert.

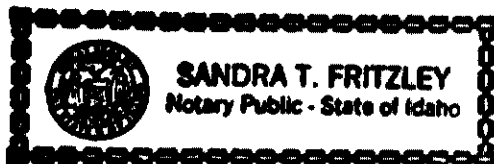

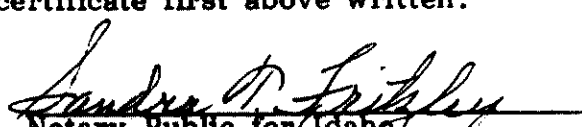
