KNOW ALL MEN BY THESE PRESENTS That the undersigned acting as the Incorporators of a non-profit corporation under the Idaho Nonprofit Corporation Act, more particularly Title 30, Chapter Idaho Code, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the Corporation is "MEYER OFFICE BUILDING CONDOMINIUM OWNERS ASSOCIATION, INC.

ARTICLE II

The Corporation shall be a non-profit membership corporation where pecuniary profit is not an objective.

ARTICLE III

The duration of the Corporation shall be perpetual.

ARTICLE IV

The purpose of the Corporation is act as the Management Body, as that term is defined in the Idaho Condominium Property Act, for the Meyer Office Building Condominiums and to provide necessary common services and to regulate and maintain common areas and limited common areas in and upon the project in Ketchum, Blaine County, Idaho, known as Meyer Office Building, a Condominium, as provided for in the terms and conditions of the Condominium Declaration and any amendments thereto for Meyer Office Building,

ARTICLES OF INCORPORATION - 1
