ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of legal age, and citizens of the United States and bona fide residents of the State of Idaho, do hereby associate ourselves together for the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to-wit:

Ι.

The name of the corporation shall be "Valley Implement, Inc."

The nature, objects and purposes for which this corporation is formed shall be:

- (a) To manufacture, buy, sell, lease, rent, and dispose of all kinds of agricultural and farm implements, and machinery and parts of every description used in connection with mechanically propelled vehicles, and other kinds of machinery including cars, trucks and all kinds of farm machinery; to buy and sell gasoline, oil, electrical equipment, spare parts, and all other materials and devices necessary to fully supply and propell and repair automobiles, mechanically propelled vehicles and machiner; of all kinds; to maintain and operate garages for the care, safe-keeping, and repair of all such automobiles, mechanically propalled vehicles and farm and agricultural machinery of all kinds.
- (b) To manufacture, buy, sell, lease, rent, and dispose of all kinds of appliances, tools, parts, equipment and fixtures for business, farm and home use.
- (c) To carry on and conduct a general merchantile business for the buying, sellin; manufacturing, leasing, renting and disposing of all kinds of merchandise, both wholesale and retail.

- (d) To buy, sell and deal in all kinds of contracts, notes, bills of sale, mortgages and other evidences of debt, and the security for the payment of the same; to buy and sell all forms of insurance and to act as an agent for insurance companies; to discount or negotiate notes, bills and other evidence of debt; to buy, sell, own and hold shares of capital stock of other corporations.
- (e) To acquire by purchase, subscription or otherwise, and to hold or hypothecate, or to dispose of stocks, bonds, or any other obligation of all kinds; and to sell, trade in and excharge the same, and all classes of stock, bonds, notes, bills of sale and other securites;
- (f) To buy, hold purchase, sell, mortgage, lease or exchange real or personal property of all kinds.
- (g) To carry into effect the object and purpose aforesaid, this corporation is authorized to do all and singular the things necessary and convenient to carry out the general purposes for which it is organized.
