**ARTICLES OF INCORPORATION**

**ARTICLE I**

The name of this corporation is "GENESEE COMMUNITY PRE-SCHOOL INC."

**ARTICLE II**

GENESEE COMMUNITY PRE-SCHOOL INC. is a nonprofit corporation within the meaning of Idaho Code § 30-305(a).

**ARTICLE III**

The duration of this corporation shall be perpetual.

**ARTICLE IV**

The purposes for which this corporation is organized are as follows:

To promote and encourage the intellectual, emotional and physical development of young children through education;

To provide a non-sectarian family-centered educational opportunity for young children;

To encourage excellence, personal responsibility and motivation and the full development of a child's potential;

To promote multi-cultural awareness, interpersonal respect and community involvement;

To cooperate with existing educational, social and governmental organizations for the purpose of expanding

educational and other support services for children of the area and their families, especially those in need; and

To do all things in connection with its objectives as permitted by law and to exercise any and all powers not prohibited by law as pertain to organizations of this type.

#### ARTICLE V

The corporation shall have one class of members, the qualifications, rights and privileges of whom shall be set forth in the By-Laws.

#### ARTICLE VI

The power to manage the affairs of the corporation and to adopt, amend or repeal By-Laws shall be vested in the Board of Directors.

#### ARTICLE VII

The Board of Directors of the corporation shall have the power to elect successive directors pursuant to Idaho Code § 30-314(f).

#### ARTICLE VIII

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under § 501(c)(a) of

the Internal Revenue Code of 1954 or corresponding provision of any future United States Revenue Law.

#### ARTICLE IX
