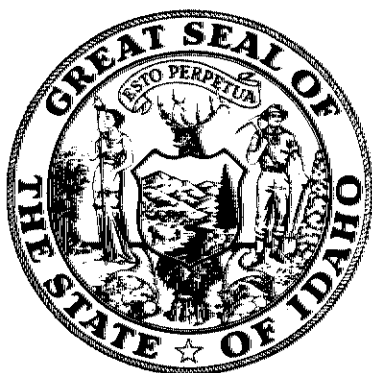

ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
DODDS-STROLBERG INSURANCE AGENCY, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Dodds-Strolberg Insurance Agency, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on January 2, 1985, in the manner prescribed by the Idaho Business Corporation Act:

A new paragraph shall be added to Article II, which shall read as follows:

"To carry on the business of selling and writing life and casualty insurance; to deal in and with contracts which undertake to indemnify another or pay or allow a specified or ascertainable amount or benefit upon determinable risk contingencies; to do all acts and to transact all business authorized by the Insurance Code of the State of Idaho or by the laws of any other states; and to carry on and conduct any other business incidental thereto within the District of Columbia, the State of Idaho, and such other states in which the corporation may hereafter be authorized to conduct business."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 2,000; and the number of shares entitled to vote thereon was 2,000.

FOURTH: The number of shares voted for such amendment was 2,000; and the number of share voted against such amendment was 0.
