ARTICLES OF AMENDMENT OF
NANCY NELSON GIACOBBI, INC.

ARTICLE I

NAME

The name of this corporation is Nancy Nelson
Giacobbi, Inc.

ARTICLE II

AMENDMENTS

The Articles of Incorporation of said corporation
shall be amended as follows:

a. Article 1 of the Articles of Incorporation
shall be deleted and the following substituted therefor:

"1. Name. The name of the corporation is
GIACOBBI, HALE & EDDY, INC."

ARTICLE III

DATE OF ADOPTION

The Amendments were approved by the Shareholders
of said corporation at a meeting held on the 1st day of May,
1982, at which meeting there was at all times a quorum of
the shareholders.

ARTICLE IV

NAME OF SHARES OUTSTANDING AND VOTING

At the time of the adoption of the Amendments,
there were ten thousand (10,000) shares of the stock of the
corporation. The holders of each of these ten thousand
(10,000) shares were entitled to vote on the Amendments, and
all ten thousand (10,000) shares voted for the Amendments.

ARTICLE V

The Amendment does not provide for an exchange,
reclassification or cancellation of issued shares, nor does
it effect a change in the amount of stated capital.
