



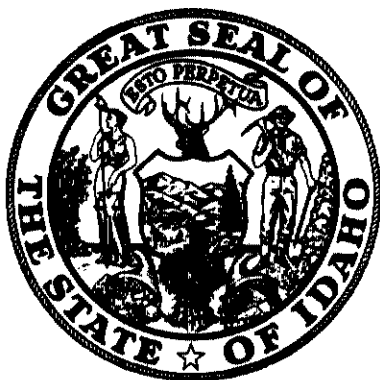
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
ALPINE PROPANE SALES, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being a natural person of legal age and acting as the incorporator of a corporation, under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the Corporation is ALPINE PROPANE SALES, INC.

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the Corporation is organized are: The retail sale of propane gas and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, as now enacted or as may be further amended.

FOURTH:

The aggregate number of shares which the Corporation shall have authority to issue is TWO HUNDRED FIFTY THOUSAND (250,000) with a par value of ONE DOLLAR (\$1.00) per share. There shall be one class of shares, all of which shall be common shares.

FIFTH:

The provisions granting preemptive rights are: None.

SIXTH:

Provisions for the regulation of the internal affairs of the corporation are: None.
