

Articles of Incorporation of the Salmon City
Cemetery Association of Lemhi County Idaho Territory.

First

The name of this Corporation shall be the
Salmon City Cemetery Association.

Second

This Association is formed for the purpose of acquiring,
holding, controlling and disposing of any and all
grounds or other property that may be necessary for
burial purposes at or near Salmon City in the County
of Lemhi and Territory of Idaho,

Third

The place where its principal business is to be
transacted shall be at Salmon City Lemhi
County Idaho Territory.

Fourth

The term for which it is to exist shall be
forty nine years from the date of its incorporation
unless sooner legally dissolved.

Fifth

The Board of Trustees shall consist of seven
persons who shall be elected annually and hold their
offices until their successors are elected, and shall be
male Citizens of the United States, and residents and
legal voters in the County of Lemhi and Territory of Idaho
and stock holders in this Association,
