ARTICLES OF INCORPORATION OF HARAMBEE CLUB, INCORPORATION A NONPROFIT CORPORATION 90 JAN 23 AM 8 40

### ARTICLE I

The name of the corporation is the Harambee Club, Incorporated, and its principal place of business shall be 420 Main Ave. South, Twin Falls, ID 83301.

## ARTICLE II

The corporation is a nonprofit corporation pursuant to the Idaho Nonprofit Corporation Act (I.C. Sections 30-301 to 30-322), as amended.

The Corporation is not organized for profit nor shall it have the power to issue certificates of stock or declare dividends; no part of the net earnings or assets of the Corporation shall inure to the benefit of, be distributable to, nor shall dividends be paid to, any member, director, officer or any other private person whatsoever. Provided that, the Corporation shall have the power to pay reasonable compensation for services rendered and to make payments and distributions in accordance with its stated purpose as set forth in these Articles.

No part of the activities of the Corporation shall be to carry on propaganda, or otherwise to influence legislation, and the Corporation shall not participate in, or intervene in (including publishing, or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the

Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (of the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law).

#### ARTICLE III

The duration of the Corporation is perpetual.

#### ARTICLE IV

The purpose of the Corporation shall be to promote the health and welfare of mental health care consumers.

#### ARTICLE V

The Corporation shall have two classes of members, those members who are on the Board of Directors, and such other members as the Board of Directors may designate, who shall not be personally liable for the debts of the corporation.

#### ARTICLE VI

The Corporation shall have such powers as are set forth in I.C. Section 30-1-4, except as set forth in ARTICLE II.

#### ARTICLE VII
