

ARTICLES OF INCORPORATION OF TEN MILE RESERVOIR AND

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, bona-fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho.

And we hereby certify, First. That the name of said Corporation is Ten Mile Reservoir and Irrigation Co., Limited.

SECOND. That the purposes for which it is formed are Irrigating, manufacturing, mining, power, domestic and other beneficial purposes.

THIRD. That the place where its principal business is to be transacted shall be Boise, Idaho.

FOURTH. That the term for which it is to exist is Fifty years from and after the date of its incorporation.

FIFTH. That the number of its Directors shall be Seven, and that the names and residences of those who are appointed for the first year, are:
