ARTICLES OF INCORPORATION OF
CLEAR MIND GRAPHICS, INC.

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, being natural persons of full age, residents of the State of Idaho, and citizens of the United States, in order to form a corporation for the purposes hereinafter stated pursuant to the Idaho Business Corporation Act, do hereby certify as follows:

ARTICLE I

NAME

The name of the corporation is Clear Mind Graphics, Inc.

ARTICLE II

DURATION

The duration of the corporation shall be perpetual.

ARTICLE III

PURPOSES

The purposes of the corporation shall be:

(a) To own, operate and manage a corporation engaged in business marketing, graphic design, web development and similar services;

(b) To engage in any and all types of business enterprises which the corporation may from time to time find necessary, desirable or convenient to do in connection with the general business of the corporation;

(c) To purchase, lease, own, sell, mortgage, sublease, or otherwise acquire or dispose of land, buildings, easements or property, both real and personal, including all types and kinds of equipment which are requisite for or are conveniently capable of being used in connection with any of the objects of this corporation, and to enter into, make, perform and carry out contracts of every sort and kind with any person, and to acquire and take over the good will, property rights or liabilities of any person, firm, or corporation,

either wholly or in part, and to pay for the same in cash, stocks or bonds of the corporation or otherwise;

(d) To engage in such other businesses or professions as may be authorized or permitted by the Idaho Business Corporation Act of the State of Idaho.

ARTICLE IV

REGISTERED OFFICE

The registered office of said corporation in the State of Idaho shall be located at 220 East River St., Ketchum, Idaho, 83340. The registered agent of the corporation is Sarah Murphy, whose address is 220 East River St., Ketchum, Idaho, 83340, and whose mailing address is PO Box 5748, Hailey, Idaho, 83333.

ARTICLE V

CAPITAL STOCK

The total authorized number of par value shares of the corporation is 10,000 shares of common stock with equal rights, and no par value.

ARTICLE VI

INCORPORATORS

The amount of capital stock of said corporation which has been actually subscribed is one hundred (100) shares, and the following are the names and addresses of the incorporators and the initial directors and the number of shares subscribed.

ARTICLE VII

MANAGEMENT

The business of the Corporation shall be managed by a Board of Directors equal to the number of stockholders. Provided, however, no person shall be a stockholder who is not engaged in the profession for which the Corporation is organized, and no person who is not a shareholder may serve as a Director of the Corporation. A Director shall hold office for the term for which he or she was named or elected and until his or her successor is elected and qualified.

ARTICLE VIII

INITIAL BOARD OF DIRECTORS

The Incorporators listed above in Article VI shall serve as Directors until the first annual meeting of the shareholders or until their successors are elected and qualified.

ARTICLE IX

BYLAWS

The power to adopt, repeal, or amend the Bylaws of the Corporation shall be in the stockholders, and the Bylaws may be amended, adopted, or repealed by a majority vote of the stock issued and entitled to vote.

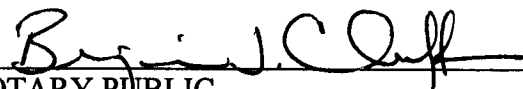
